

**ORDINANCE NO. 2022-03**

**ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE  
PRAIRIE SKIES PUBLIC LIBRARY DISTRICT FOR THE FISCAL YEAR  
BEGINNING JULY 1, 2022 AND ENDING JUNE 30, 2023**

**BE IT ORDAINED** by the Board of Library Trustees of the **PRAIRIE SKIES PUBLIC LIBRARY DISTRICT**, comprised of parts of Cass, Menard, Morgan and Sangamon Counties, Illinois, as follows:

**SECTION ONE:** That the total amount of appropriations for all corporate purposes legally made to be collected from the tax levy and other funds of the current fiscal year beginning July 1, 2022 and ending June 30, 2023 is hereby ascertained to be the sum of THREE HUNDRED SIXTY-THREE THOUSAND AND FIVE HUNDRED DOLLARS AND 00/100THS (\$363,500).

**SECTION TWO:** That the amount of FOUR HUNDRED AND THREE THOUSAND DOLLARS AND 00/100THS (\$403,500), being less than the total of appropriations heretofore legally made which are to be collected from the tax levy and other funds of the current fiscal year of the PRAIRIE SKIES PUBLIC LIBRARY DISTRICT for all corporate purposes of said District, for purposes of providing for a Corporate Fund, Audit Fund, Insurance Liability Fund, Social Security Fund and Building Maintenance Fund as appropriated for the current fiscal year by Ordinance No. 2023-02 of the PRAIRIE SKIES PUBLIC LIBRARY DISTRICT passed at the legally convened meeting of September 13, 2022, which is hereby incorporated herein and made a part hereof by this reference, be, and the same is, hereby levied upon all of the taxable property in the PRAIRIE SKIES PUBLIC LIBRARY DISTRICT subject to taxation for the current year, the specific amounts as levied for the various funds heretofore as named being included herein by being placed in separate columns under the heading "To Be Raised by Tax Levy" which appears over the same, the tax so levied being for the current fiscal year of said District, and for the said appropriation to be collected from said tax levy, the total of which has been ascertained as aforesaid.
